Reservation and Payment Terms

This document sets out the reservation and payment terms for stays at “Kozilasek” (hereinafter referred to as the “Property”). The document is available on the website and is provided to the Guest as an attachment when a reservation is made online. Making a reservation constitutes acceptance of these terms.

- Reservations can be made by phone, e-mail, or via the online booking form available on the Property’s website.
- As a rule, confirmation of the reservation requires payment of the full amount for the stay, unless the parties agree otherwise by e-mail, by phone, or in another mutually agreed manner.
- A reservation is considered confirmed once the conditions indicated by the Property have been met, in particular after: (1) acceptance of the reservation terms provided in the e-mail message and (2) the payment being credited to the Property’s bank account, unless otherwise agreed individually. In the case of reservations made shortly before arrival, we kindly ask you to additionally send confirmation of the bank transfer.
- For reservations made in advance, payment should be made within 48 hours of receiving the e-mail message, unless agreed otherwise. After that time, the reservation may be automatically cancelled.
- Changes to the reservation (stay dates, number of guests, invoice details) require contacting the Property and are subject to availability.
- Free cancellation is possible up to **7 days** before the planned arrival.
- In the event of cancellation less than **7 days** before arrival, the Property may retain all or part of the paid amount as a cancellation fee, especially if the cancelled dates cannot be resold.
- In the event that the Guest does not arrive on the day of arrival or shortens the stay after check-in, no refund will be granted for unused nights.
- Payments are accepted by bank transfer or by card via a payment terminal. As a rule, cash payments are not accepted on site. Cash payment is possible only if agreed in advance and after an invoice has been issued to a company.
